- 16. Conditions under which bidders' representatives can participate in the bid opening procedure: The opening of bids is public and can be attended by any interested person. Only authorized representatives of bidders can actively participate in the bid opening procedure. Present

representatives of bidders must submit certified authorizations for participation in the bid opening procedure to the commission before the public opening of bids begins.

In case the bid is submitted by a group of bidders, on the envelope or box, it is necessary to indicate that it is a group of bidders and to state the names and addresses of all participants in the joint bid.
